Gatekeeper Announces New Purchase Orders of \$2.255 Million

Abbotsford, BC July 27th, 2016 - Gatekeeper Systems Inc. ("Gatekeeper" or the "Company") (TSX.V: GSI; OTC: GKPRF; FSE: 1GK) is pleased to provide an update on the continued sales momentum as the fourth quarter ending August 31, 2016 approaches. Further to its press release dated June 21, 2016 where the Company reported an aggregate of \$1.686 million CDN in backorders, it has received additional purchase orders totaling approximately \$2.255 million CDN during the period of June 22, 2016 to July 20th, 2016.

President and CEO Doug Dymant stated, "Customer acceptance of our high-definition platform, wireless connectivity solutions and service systems are gaining momentum in our base business. Shipped sales, new orders and the growing backlog indicate our business strategy is working – our Gatekeeper team is working hard to deliver positive results as we enter into the last six weeks of the fourth quarter." Dymant also added, "The diverse product line we have brought to market over the past two years is attracting new partners and driving strong interest with end users providing a base for future growth."

The Company also announces that it has granted, subject to regulatory approval, an aggregate of 1,096,250 incentive stock options under the Company's Stock Option Plan to directors, officers, employees, and consultants of Gatekeeper. The Options will be exercisable at a price of \$0.195 for a period of 10 years from the grant date, and subject to vesting provisions.
