Our technology platform can be expanded to road safety solutions and help save lives by deterring speed violations in all municipalities”.

Fines for stop arm violations average between \$250.00 and \$350.00. Counties have now passed law that allows them to use video from a school bus video system as evidence to issue a ticket and prosecute the owner of a vehicle that passes a school bus while the stop arm is engaged.
